## **Springer Hosts** Renowned Psychologist

The Springer School was pleased to host Dr. Robert Brooks as its first Annual Distinguished Speaker. Dr. Brooks is Director of Psychology Training and Community Liaison at the Hall Mercer Center for Children and Adolescents of the McLean Hospital and a faculty member of the Harvard Medical School.

Dr. Brooks gave an inservice for faculty and staff on Monday, November 12. That evening he addressed parents and interested community members following a banquet at the Omni Netherland Hotel. His topic was "Fostering Self Esteem in Children and Adolescents: The Search for Islands of Competence."

The core of Dr. Brooks' message was that any child, though he may be frustrated by his inability to learn some skills easily, has his own peculiar strengths which educators and parents need to identify and use as building blocks. Development of the "islands of competence" is a critical part of building self esteem, and once a child feels good about himself he is freed to fully learn and grow.

## Tricks of the Trade by Mary Inkrot Schroder - Primary Principal

In the age of VCR's and video games we may forget how much we continue to rely on the written word. Here at Springer, learning to read is not a simple task for many of our children, but some creative "learning tricks" going on in the classroom have brought about good success in this area. The following anecdote draws a parallel between what happens in the story and what happens in the classroom.

Illustrator Ed Young has created a beautiful version of a classic Chinese tale very much like the folktale <u>Little Red Riding Hood</u>. Lan-Po-Pa, a wolf disguised as an old woman, tries to trick three children whose mother has had to leave them alone. The children prove, however, to be more clever than the wolf could ever imagine. In the same way, our childrens' learning problems, like the wolf, get in the way of what they want, which is to read. But, through clever learning tricks, they find they can read better than they would have thought possible.

This story came alive for the children in one Primary classroom. Their teacher read the children the story and then allowed them to use puppets to discuss and act it out. Later the students wrote their own versions of Little Red Riding Hood with some unique ways to trick the wolf!

In another classroom a child was tracing the letters "ck" before making the "ck" sound. The child seemed to remember that sound as she felt those letters being formed with her fingers. Her daily practice of hearing, feeling and saying the sounds are now helping her to form words and open the door of reading for her.

The oldest Intermediate class is incorporating literature into their reading program. Recently <u>The Enormous Crocodile</u>, by Roald Dahl, was presented. Word searches for vocabulary development, character maps and designing bookcovers were just a few of the activities the students engaged in.

In each of these learning experiences the students seemed to be on a mission to learn to read. They were using tricks which worked for them. How exciting it is to see the children discover the thrill of reading!

# Exxon Continues Math Program Funding

**Shelly Wiesbacher**, Springer's curriculum director, recently learned that the Exxon Education Foundation awarded a second grant to the school to allow the continued development of a new math curriculum for our primary level classes.

This was really good news because Shelly has seen exciting changes occuring since the decision to move math instruction away from a computation based model to one where the child is encouraged, through the use of manipulatives, calculators and computers, to explore new and broader mathematical concepts he would ordinarily not be introduced to. Four units of study were selected for the first year of the program: problem solving, estimation, patterns and geometry.

The year ended with a marvelous display of geometry projects lining the main hall of the school. The very youngest class created a jungle filled with geometric animals. Other classes made geometric shape mobiles and stained glass symmetry designs.

Springer's math teachers were also busy during the transition with ongoing inservice training and constant evaluation of the new approach. "Math became fun and real — not just moving numbers on paper," is how one teacher summarized her impression of the new approach. Another teacher was most impressed with the change in the children. They began to display excitement over the ability to interact with materials and see math as a part of life, not just routine computation.

This year, the math program will focus on statistics and probability, whole number computation, algebra and decimals.
